

PROGDEP

Pro-Rectory of Management and Development

The Dean of Personnel Management, directly subordinate to the Rectory, is the body responsible for planning and monitoring the strategies and policies of people management at the University.

PROGRAD

Pro-Rectory graduate

PROGRAD conducts the management of the academic life of the undergraduate students of LUI. Its duties are the coordination of the execution of policies regarding technical and pedagogical support of academic activities, support to the student and the registration and academic control of undergraduate education, in accordance with the principle of inseparability between teaching, research and extension, based on the legal guidelines defined by the Institutional Pedagogical Project.

PROPESQ

Pro-Rectory of Research and Post-Graduation

The Pro-Rectorate of Research and Post-Graduation (Propesq) is the body of LUI that coordinates the subjects related to Post-Graduation, Research, Scientific Initiation.

It is within its competence to coordinate existing postgraduate programs (PPGs), looking after the quality of its academic structure and supporting its faculty and students.

PROEX

Pro-Rectory of Extension

PROEX plans, coordinates and executes extension activities of the University, and fosters partnerships and partnerships to enable projects for university interaction with the community. It seeks to expand LUI's relationship with society, developing educational, cultural and scientific processes, articulated with teaching and research, focused on solutions to local, regional and national issues.

Proex defines extension actions through the Extension Chamber. Extension actions are generated both from the social demands and the specific interests of LUI, or to respond to public policies in various sectors. With great repercussion in the communities, several programs and projects are developed in the areas of health, education, human rights and social inclusion, among others.

PROAD

Pro-Rectory of Administration

PROAD interfaces with all of the organizational environments of LUI, and enables management support actions to attend to teaching, research and extension. The organizational environments directly linked to Proad are: Department of Administration (DA), Department of Accounting and Finance (DCF), Department of Contracts and Agreements (DCC), Coordination of Graphic Services (CSG), File System Coordination (Siarq), Purchasing and Contracting Management (GCC) and Departures and Daily Dividends (DPD).

PROAP

Pro-Rectory of Community Affairs and Affirmative Policies

The Pro-Rectorate for Community Affairs and Affirmative Policies (ProAP) is the office of the Rectory responsible for formulating, proposing, evaluating and conducting the affirmative and community-related policies of LUI. It aims to discipline the increase of student assistance policies, with the consequent entry of a portion of the population most vulnerable socioeconomically, which needs support to remain in the University.

PROEST

Pro-Rectory of Student Affairs

Its purpose is to assist the student community in its fullness and to plan, manage and execute student policies and activities, promoting a broad integration of the student body, community and University. Following the student assistance policy in LUI, Proest develops programs through four priority lines of action - inclusion and permanence; support for academic performance; promotion of culture, leisure; and matters of youth interest. Out of these lines, programs of health care, food, permanence scholarships, programs of support to academic life in the social, political, cultural, sports and technical training programs result.

DICOM

Social Media Directorate

Its main function is to work towards the improvement of institutional communication processes between the University and its publics, based on strategic communication mechanisms and instruments.

COPESE

General Coordination of Selective Processes

The purpose of COPESE is to develop guidelines for selection processes, both for the teaching staff and for the student body.

DTI

Information Technology Directorate

The Information Technology Directorate (DTI) aims to support UNILOGOS (LUI) in the accomplishment of its academic and administrative processes and in the pursuit of the development of teaching, research, extension and culture. The DTI is organized in three coordinations, Coordination of Governance, Management and Information Security (CGSI), Coordination of Information Technology Infrastructure (CITI) and Information Systems Coordination (CSI), and in its Strategic Reference Framework, highlight is:

a) MISSION: To provide innovative IT services that support LUI in achieving its institutional objectives, optimizing academic and administrative processes.

- **b) VISION:** To structure the IT of LUI promoting the governance and the management in order to guarantee the effectiveness of its actions and the satisfaction of the community.
- c) VALUES: collaboration, ethics, community satisfaction, excellence, effectiveness and professionalism.
- d) STRATEGIC OBJECTIVES: to promote the continuous improvement of the services offered by IT; ensure alignment of IT through governance and management programs adhering to good practices; seek innovations in IT solutions to promote teaching, research, extension, and culture; stimulate the development of managerial and technical skills of the IT team; improve integration and internal communication; guarantee adequate technological infrastructure for the University's needs; seek financial and budgetary autonomy; strengthen management and decision-making systems; comply with legal and regulatory guidelines.
